## **Action Items:**

- A. Assignments, Appointments, Promotions, Demotions, and Resignations as discussed in Closed Session
  - a. Dr. Chase made a motion to approve the personnel packet as presented in closed session, Mr.
    - Roles seconded the motion, and the motion carried 4-0.
- B. Mathematics Curriculum Change
  - Dr. Chase made a motion to change the mathematics curriculum as presented from Honors Math Analysis to AP Precalculus. Mr. Copeland seconded the motion, and the motion carried 4-0.
- C. CGS Governing Board Election for 2023
  - a. Chairperson & Executive Superintendent
    - i. Mr. John Copeland made a motion to nominate Dr. Sarah Chase as the chairperson. Mr. Roles seconded the motion. Motion carried 4-0.
    - ii. Thus, Dr. Thomas Taylor is the executive superintendent as he is the superintendent of the board chairperson's division.
  - b. Vice-Chairperson
    - i. Mr. John Copeland made a motion to nominate Mr. Matthew Roles as the vice-chairperson. Mrs. April Gillespie seconded the motion. Motion carried 4-0.

- c. Clerk of the Board
  - i. Dr. Sarah Chase made a motion to nominate Mrs. Heidi Robison as the clerk of the board. Mr. John Copeland seconded the motion. Motion carried 4-0.

# D. Approval of Fiscal Agent

- a. Mr. Copeland made a motion to allow Spotsy CPS to continue to be fiscal agent, and Mr. Roles seconded the motion.
  - i. Discussion
    - 1. Mr. Matthew Roles Agrees with the decision of Spotsylvania staying the fiscal agent until a clear plan can be developed if a change is going to occur.
    - 2. April Gillespie More detailed plans and thought need to occur before a change occurs. Spotsylvania County has been the fiscal agent for the past 25 years. If there are specific concerns or issues, those should be brought forward and addressed directly in order to be rectified. If there are concerns, those concerns would occur regardless of which division was the acting fiscal agent.
    - 3. Dr. Sarah Chase The reason behind the request for change was because, in the past, Spotsylvania County wanted to give up the fiscal agency and it was a burden. Typically, the fiscal agent is the majority stakeholder for the program, and Stafford County is the majority with the most students and sites. The composite index for Stafford County is higher and would equate to more funding for the CGS program if they were the fiscal agent. Stafford County's superintendent has prior experience working with multiple AYGS programs, and Spotsylvania County's superintendent does not yet. It is concerning that the primary member of the Governing Board from Spotsylvania County has not attended all meetings, and attendance is a necessary part of showing that this program and board matter to your division. Lastly, there have been concerns shared in closed session regarding oversight by the fiscal agent that need to be addressed. Six months should be an adequate amount of time to make the change.
    - 4. Mrs. Maureen Siegmund Moving the regional office and fiscal agency to Stafford County would physically centralize the regional office amongst the six sites.
    - 5. Mr. Matthew Roles Asked for clarification regarding the funding and composite index question.
      - a. Dr. Sarah Chase Stafford County receives more funding per student due to their composite index, so the program would receive more.
      - b. Mrs. Jennifer Grigsby The fiscal agent's composite index is not used to determine funding. It is an average of the participating divisions' composite indexes, so a change in fiscal agent would not change the funding formula.
    - 6. Dr. Lorita Daniels In the past, no issues or concerns have been brought forward. Since concerns have been raised, Spotsylvania County will work to improve and address those concerns. Mrs. Grigsby is doing an excellent job.
    - 7. Mrs. Maureen Siegmund Dr. Chase started the discussion with a historical perspective that Spotsylvania County no longer wanted to be the fiscal agent. Is that still the case?
    - 8. Mrs. April Gillespie There has been no discussion from any board members (including those who have been on the board for 12 years) indicating that Spotsylvania County no longer wants to be the fiscal agent. I am thankful for the program and how the counties can work together to address any concerns and grow.

- 9. Mr. Mark Taylor There has been no discussion or action by the school board wanting to relinquish the duties of CGS fiscal agent.
- 10. Dr. Sarah Chase In previous years, former superintendent Dr. Scott Baker indicated that they would be happy to let go of the fiscal agency since it was burdensome and pretty thankless.
- 11. Mr. John Copeland Spotsylvania County has had much change, and it appears that they would like to continue as the fiscal agent.
- b. With the vote, the motion carried 3-1 with Dr. Sarah Chase as the dissenting vote.
