- Teachers finished instruction toward the end of April in all AP classes in order to leave some space for AP review prior to the start of testing.

Approval of Consent Agenda - Mr. Copeland motioned to move meeting minutes from March 23 and Board retreat from March 25, 2023 and financial report to action. Mr. Roles seconded the motion, motion carried 3-0

Informational Items -

- 2023-2024 Governing Board Meeting Dates Mrs. Grigsby will send out calendar invites in June.
- End-of-Year Director's Report (Adding Dr. Calveric into meeting through Zoom) Areas of focus based on 2015 and 2021 evaluations that were reviewed at March 25, 2023 retreat.
 - Strong Instruction Strategies & Student Engagement (started 2018 with new director)
 - John Hattie Visible Learning
 - Mrs. Grigsby is asking for 3-4 strategies from the teachers. She tabulates all the data and identifies areas that teachers can grow and sets goals for the next year. Teachers identify areas they want to get stronger in and identify areas students are weak in . Most are able to do 5-7 strategies. There has been a lot of growth in the 5 years this has been implemented.
 - Mr. Roles asked how the international average gets identified, and the College board provides the numbers.
 - Outreach to Younger Gifted Students
 - KGHS did not do STEM/STEAM because they have a division wide STEM/STEAM night.
 - Feedback Stafford is looking to expand to 7th grade and Spotsylvania is looking to expand to 6th grade.
 - Implementation & Adaptation of Mathematics...CGS Students
 - 2021-2022 transition year Juniors & Seniors took AB Calculus.
 - 2022-2023 Juniors took AB Calculus and seniors took the BC Calculus
 - 2023-2024 AP Precalculus will replace CGS Honors Math Analysis
 - Co-teaching model in Spotsylvania County is going very well, they are getting small group feedback. The teachers are learning from each other. Example: younger teacher is gaining content knowledge and older teacher is gaining engaging strategies. Want to continue for one more year and then evaluate it. Then see if it can expand to the other counties.
 - Dr. Chase questioned how this works with SOQ standards. You end up with a 15 to 1 ratio when the state requires 24 to 1. There is a cost because you are paying for an additional teacher.
 - Gifted Endorsement of Teachers Participating in Region 3 cohort with Shenandoah University. Four staff members will complete this year. The other six are in the process. Thankful that the counties are helping cover funding for teachers to get their endorsement.
 - Retention & Meeting the Needs of Students average departure is 9% annually, goal is 5%. Currently at 7%.
 - Next year's goals creating a 5 year strategic plan, identification of areas of academic weakness, creating a plan of attack to address the weakness, and continuation of previous work.
 - Questions NA
- Director's Handbook DRAFT
 - Mr. Roles questioned the differences in Handbook versus the discussions at the retreat, flow chart different. Changes were made to reflect requested changes.
 - o Mr. Wolfe questioned where the flow chart should name him or should it say

- "Fiscal Executive supervisor". Dr. Taylor points out that this is how it was discussed in the Governing Board retreat. The handbook will be slightly different.
- o Dr. Chase would like to see the flowchart in the Director Handbook
- Dr. Chase questioned about adding something about the hours the Director is scheduled to work and Spotsylvania remote work policy.
- Dr. Chase asked what is SSWS (Single Sign-on Web System). Dr. Taylor explained that it is state sign on for grants, admin function reports, master schedule, school reports, etc.
- Finance Committee Meeting Minutes May 10, 2023

Attendance - Jennifer Grigsby, CGS Director, Heidi Robison, CGS Program Manager, Chris Fulmer, Stafford County Deputy Superintendent & Chief Operating

Minutes

- The meeting began at 8:32am.
- Mrs. Robison and Mrs. Grigsby went through the budget document providing an overview and changes that have occurred over time with the budget. They also answered questions from Mr. Fulmer throughout the meeting.
- Regional Office Personnel All numbers in this section are provided by Spotsylvania County as the fiscal agent. Any raises or steps are given following the practices of Spotsylvania County for their employees for the upcoming year. Although this is state funding and not directly part of Spotsylvania County's budget, the salary and benefits practices follow that of the fiscal agent. Mr. Fulmer had questions regarding some of the benefits, specifically hospitalization. Is Hospitalization the health care benefits for the regional staff? If so, how do those break out? He planned on emailing Prashant Shrestha, Chief Business Officer of Spotsylvania County Public Schools, to obtain answers to his questions.
- Program Instructional Development
 - In most of these categories, increases were made based on actual spending in FY23.
 - Multiple lines, 2.6 Computer Hardware, 2.6 Computer Software, and 2.6 Guidance, were new lines added this year, which accounts for the \$0.00 current allocation and the justified increases. Mrs. Robison has been trying to add lines slowly as she adapts to the spending trends in order to have a better showing of expenditures.
 - Program Technology
 - 3.1 Verizon Maintenance went from \$70,000 to \$0.00 due to the cancellation of some of the internet services. Over the next four years, CGS plans to integrate our program into the technology services provided by each of the schools since they all now have reliable and high-speed internet across all schools. This was not the case when the program first began utilizing these services for the Tanberg broadcast system.
 - 3.3 Technology Maintenance/Upgrades have also decreased due to Chromebooks being available to all students in most divisions. Each site has access to new Chromebook carts for students without a device (either from lack of resources, lack of distribution for some divisions, or lack of remembering to bring it that day). Additionally, the CGS probeware connects automatically to the CGS

Chromebooks housed on site without needing special permissions on student individual Chromebooks from their divisions.

- Regional Office Operations
 - Decreases in many of the costs of running the regional office were decreased by changing leases to better match output.
 - There is a large increase in travel for FY24. Spotsylvania County has indicated that they plan to rescind use of the CGS car after the retirement of the current Network Engineer. If that occurs, then the CGS Network Engineer will need to be reimbursed for mileage along with the CGS Director, CGS Program Counselor, and the CGS Program Manager. The car was initially allocated due to the Network Engineer needing approximately \$1000 per month in travel reimbursement. Spotsylvania County felt it more prudent for their audits to provide him with a vehicle.
 - Tuition assistance is provided to students for the DE Chemistry course through Richard Bland College. All juniors take DE Chemistry for a total cost of \$275. CGS pays \$75 per student for the course. Students are responsible for the other \$200. Richard Bland College also provides CGS with 20 free seats for students who qualify for free or reduced lunch. Part of the decrease is due to no longer covering the annual tuition of a student who transferred from Spotsylvania County to Caroline County. The rest is due to class size.
 - Assistance to Participating Divisions
 - Fire & Liability Insurance is purchased annually to protect CGS in case of any accidents with staff or students. Previously, a student was injured in a laboratory experiment, and the student's family brought about litigation against the school divisions and CGS.
 Although found not culpable, it was recommended by legal services to obtain a separate policy for CGS, which has been in place since.
 - VSPA Grant Awarded annually for the same amount and able to be used for specific technology purposes.
- Mr. Fulmer requested historical budgets with actual expenses as soon as possible and additionally a detailed spreadsheet ledger of expenses that are delineated by subject, site, etc.
- Mr. Fulmer also recommended a mid-year meeting to review expenditures up until that point in time and meeting again in late April/early May prior to the final budget being voted upon by the Governing Board.

The meeting adjourned at 9:05am.

 - Who does personnel cover? It would cover any future positions.
 - Mr. Roles motioned to approve Joint agreement as amended, Mr. Copeland seconded the motion, motion carried 3-0
- Evaluation Process for CGS Director attached to the board packet "Guidelines for Uniform Performance Standards and Evaluation Criteria For Principals"
 - Mr. Wolfe questioned the date for step 3 & 4, the consensus was the dates were accurate to allow enough time for those involved to provide feedback.
 - Dr. Chase the evaluation process follows the same as principals are currently using.
 - Mr. Copeland motioned to approve Evaluation Process, Mr. Roles seconded the motion, motion carried 3-0
